On 02/14/2021 at 2111 hours I arrived at 29 Golf Terrace Dr. #301. My response was in reference to a family disturbance. Upon my arrival I came in contact with the victim who was later identified via her name and date of birth as, Desiree England. Desiree stated the following in a sworn written statement:

She was home in her locked bedroom when her recently separated boyfriend, Edwin Morales, came home from a night out. Edwin entered the locked bedroom with a butter knife as a key. Desiree believed Edwin to be intoxicated she requested him to leave the apartment. Edwin continued to take off his shoes and ignore her requests. Desiree grabbed his suitcase that was previously packed and threw it towards the corner of the room telling him to leave. Edwin still had the knife in his hand during the argument. Desiree then grabbed the knife from Edwin and threw it in the corner of the bedroom. Desiree then knocked his hat off his head, Edwin then grabbed her by her throat and punched her in the face. He then pushed her onto the bed continuing to strike her in the face. During this time he still had a hold of her by the neck, she was struggling to get up but was not able to get away from him. She then struck him back in an attempt to get him off of her. Edwin then followed back with six more strikes to her face, closed fist, right hand. Desiree stated she yelled for her friend Brianna. Brianna then called the Winter Springs Police Department. Edwin then collected some belongings and left.

As a result of the incident, Desiree sustained scratches to her right arm, a laceration to the inside of her lip, bloody nose, swelling on her face and left eye, as well as scratches to her face and neck.

I then spoke with a Brianna Bahus, who was identified via her Florida Driver License. Brianna stated the following in a sworn written statement:

She heard her name being yelled by Desiree in the bedroom and what sounded like a struggle was going on. Once she entered the room she saw Desiree bent over the bed with Edwin on top of her pinning her to the bed with a knife in his hand while the same hand clutching her shirt holding her down. Brianna then grabbed the knife and told him to leave. She then started to call the Winter Spring Police Department as he then left the residence. Brianna believes the knife was clutched in his hand but not in an attempt to harm Desiree with it.

Officer Roman was able to make contact with Edwin not far from the apartment and detained him. Edwin stated the following:

He returned home from a night out with his friends and family. When he got home he entered the room stating it was already unlocked. When he got into the room he sat at the end of the bed taking off his shoes. Desiree then woke up and started to question him about where he was and an argument ensued. Desiree then grabbed his belongings and threw it into the corner near where he was sitting telling him to leave. She then got into his face. He then pushed her away from him. He then pinned her down to prevent her from swinging at him but was able to hit his face and claw at his neck. Her friend then entered the room and he got dressed and left immediately.

During my investigation, I determined Edwin violated F.S.S 784.03 (1) (a) (1) (Domestic Violence Battery), when he intentionally hit Desiree in the face repeatedly against her will. Edwin and Desiree have been dating for over a year and resided as a family for many months.

I then completed the Domestic violence paperwork, as well as provided Desiree with a Victims Rights Brochure per Amendment 6.



Assisting Officer Roman placed Edwin into custody and transported him to the Seminole County Jail without incident.
